We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2017-18 educational progress for Patterson Elementary. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2017-18 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no label is given. Our school has not been given one of these labels.

In Holly Area Schools, students are assigned to neighborhood schools, established by Central Office. In addition, Holly Area Schools accepts School of Choice students, as openings are available. Families interested in enrollment or school of choice options can contact the Holly Area Schools Pupil Personnel Office at 248.328.3100.

Patterson Elementary follows the Holly Area Schools curriculum, and is fully aligned with the Michigan State Standards. Our teachers, with the support of the Office of Curriculum, review, update, and assess the effectiveness of pacing guides, instruction, and assessment.
